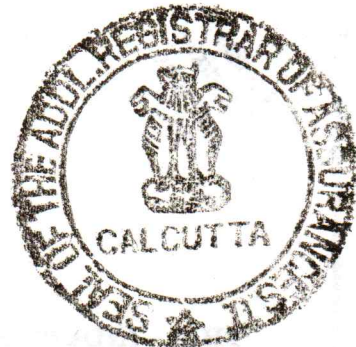

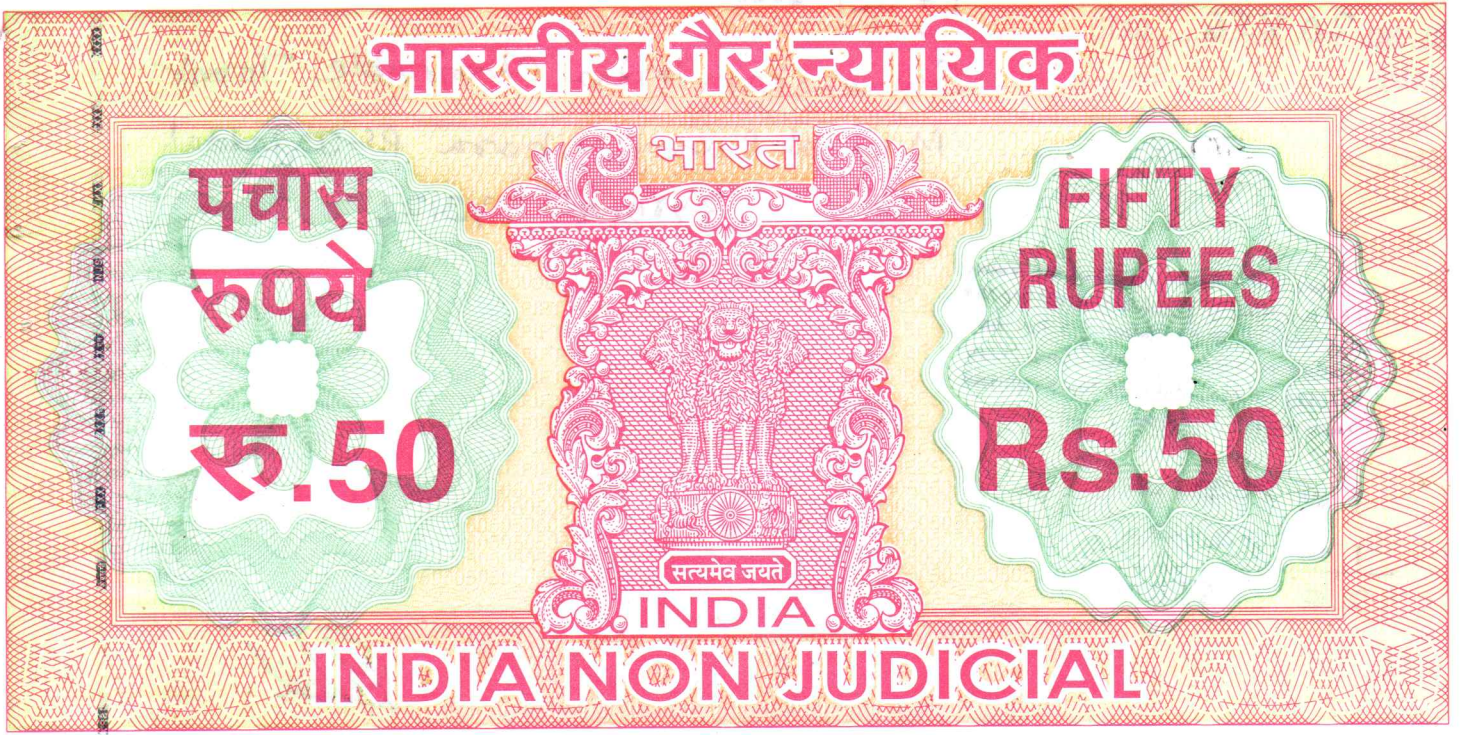

Whereas the Settler is desirous of establishing a trust for Non Commercial , Non Profitable Public Charitable Objects. And whereas the trustees have, at the request of the settler, agreed to act as the first trustees of these presents as testified by their being parties to and executing these presents.

And whereas it is necessary to declare the objects and terms of the Public Charitable Trust, being constituted under these presents.

Now this indenture witnessed as follows

1. That in order to effectuate his aforesaid desire, the settler has set apart and handed over to the trustees, a sum of **Rs. 10,000/- (Rupees Ten Thousand only)** and hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and

the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained and Not any immovable and or movable properties as of now and allows the trustees to have and to hold the same in trust as corpus of the trust , to be used by the trustee to carry out and fulfill the objects of the trust setforth herewin , and the settler of the trust hereby relinquishes for all time any claim to or interest in the said assets or fund forming the subject matter of the Trust.

2. That the name of the trust shall be -

SWACHETAN INDIA CHARITABLE TRUST

(Non Commercial, Non Profitable Charitable Trust)

and its Rented office shall, for the present be situated - : MADRAL BANERJEEPARA HARITAKITALA , PO. MADRAL, PS. BHATPARA, DIST. NORTH 24 PARGANAS, PIN CODE. 743126 , STATE- WEST BENGAL, INDIA . The organization will have jurisdiction over the area of West Bengal as well as all over India. The Office address mentioned above is Rented & used only for correspondence purpose and it is not the Trust property.

3. That the objects for which this trust is established are : in charitable purpose as defined in charitable Act. 1920 and Income Tax Act. 1961 as follows : That the aims & objectives of the trust shall be of general public welfare and other charitable purpose including relief of the poor , education , medical relief and advancement of any object of public utility not involving the carrying on of any activities for profits as defined under the income tax act, 1961 and / or under any order for the time being in force under the income tax act and or any stationary modification thereof . Besides such objectives in general the Trust will mainly work with the sphere of drug and other chemical substance abuse and without prejudice to the generality of the aforesaid and the following shall be deemed to be the principal objectives of the Trust .
- I. To establish, promote, set up, maintain, or maintaining and or running Play School, KG School , Nursery School , CBSE School, ICSE School, School.
 - II. To grant, pay or give scholarship, stipends prizes, Sports items, rewards, allowances and other financial assistance or help in cash or kind to students. To run , establish library and reading rooms in needy communities.
 - III. To arrange and organize annual sports, cultural activities , functions and competitions, picnic, Eco Tourism , educational tour programmes etc.
 - IV. To celebrate , observe the Birthday of the Great men of the Country, Red Letter Days, Festivals etc. in order to uplift the morality of the students.

To establish, promote, set up, maintain, run Medical College , Nursing Colleges, Dental College, Para Medical College , Spiritual Colleges Pharmacy College , Physiotherapy College , Biological and Biomedical College, Hospitality & Tourism Management College, , Polytechnic College , Law College , Management College, Engineering college , Architecture College, Arts & Science College , Agriculture & Horticulture College, Knowledge Hub.

- XIII. To raise the legal status of animals to reflect their status as sentient beings, including protection in national laws.

- XLI. To promote, establish, maintain, undertake Pathology Centre, Diagnostic Centre, Dispensary, Pathology collection centre , Crèches (day care centre) , Drug centre in the Rural, Urban & Semi Urban Area for the benefit of people. To Run ayurvedic, yoga, pranayam and homoeopathic clinics and centers .

- XLIV. To help and generate training programme for self employment of women and educated unemployed people and to work for adult education.
- XLV. To conduct , maintain , meetings, conferences, workshops, seminars, Fair on various Social Development issues .
- XLVI. To make self sufficient, such unemployed women by giving educational and vocational training. carry out , formation and undertake groups of persons belonging to the poorer sections of society based on Govt. Recognized concept of Self Help Group (SHGs) .
- XLVII. To cultivate the spirit of culture among the member of the trust by function and cultural functions etc.
- XLVIII. To make self sufficient, such unemployed prostitute women by giving educational and vocational training.
- XLIX. To work with women who are socially disadvantaged and economically exploited and works for their social upliftment and economic emancipation. To promote Prevention Trafficking by Awareness Generation, counseling & Advocacy.
- L. To work, start, run ,maintain of rural development programme ; Horticulture, Pisciculture, Animal husbandry etc. For the sake of all round agricultural development and training.
- LI. To undertake project / action programs for benefit of child labour and women labour so to enable them to participate actively in the socio-economic development.
- LII. To give , maintain appropriate vocational skill training to youth & Tribal Affairs after proper demand assessment to facilitate employability and create options for non-farm livelihoods & Income generating programme .
- LIII. To establish / run / manage hospitals, research centre , health centers, mobile health clinics, research centre to provide health care, counseling for all kinds of illness and deceases.
- LIV. To help and generate training programme for self employment & to run entrepreneurship development programme for the women and unemployed youth ; establish small scale enterprises and to work for adult education.

- LV. To print, publish or/and distribute books, magazines, Journal, newsletters or any other literature in print or digital media for the promotion of the Trust objects.
- LVI. To acquire or obtain on lease or in other manner, land, buildings, furniture, equipments, stores and other requirements for the purpose of the trust and the institutes etc. to be run by it and to sell, exchange, lease, mortgage or deal in any other manner with the movable and immovable properties of the trust and its institutes etc, run by it

5. PROPERTIES:

The Trust properties shall consist of-

- a) The amount Transferred by the SETTLER as mentioned above, towards the Corpus fund of the Trust.
- b) Any cash, kind, properties, movable and immovable that may be acquired by purchase or otherwise or all manner of rights, title or interest in or over any property movable or immovable
- c) All additions and accretions to the Trust properties and the income there from
- d) All donations, gifts, legacies or grants, in cash or kind accepted by the Trustees upon Trust with proper Norms & Legal Documents / Receipts .

The properties of the Trust shall be utilized for the objects set forth herein above and subject to the provisions and conditions herein mentioned.

6. NUMBER OF TRUSTEES, THEIR TERM AND POWER TO CO-OPT:

The Trust will be managed by a Board of Trustees consisting of not less than 3 trustees and not more than 15 trustees . The parties of the Second Part will be First Trustees and they shall automatically form the Board of Trustees

The term of office of First Trustees shall be for their respective lives. The Board of Trustees shall have the power to increase the total number of Trustees up to the maximum number stated above and fix their term as per provisions contained herein.

Any Trustee, including the Chairman (Managing Trustee)may retire from the Trusteeship hereof by giving two calendar months notice in writing of his or her intention to do so, to the Board of Trustees and after the expiry of the period of notice, the Trustee giving the notice shall If so fact to cease to be a Trustee of these presents.

Any vacancy caused by death of any one of the First Trustees, or any vacancy caused by the resignation of any of the Trustees, may be filled up by co-option by the Board of Trustees.

The Trustees who are not First Managing Trustee or First Trustees shall hold office for a period of one year from their date of appointment by the Trustees. At the end of this one year period, the Board of Trustees may reappoint them for subsequent term or appoint other persons as Trustees in such a manner that

the total number of Trustees does not exceed the approved maximum number of Trustees.

The Chairman (Managing Trustee) shall have the power to remove a Trustee suffering from physical or mental disability or if he is accused of misfeasance of trust funds or property or misconduct, after satisfying himself on enquiry and such action of the Chairman (Managing Trustee) shall be final.

The proceedings of the Board of Trustees shall not in any way be invalidated due to any post or posts remaining vacant. During the time when a vacancy is yet to be filled up, the remaining Trustees shall act as "Full Board", subject to the presence of Quorum in the meetings. Any vacancy in the Board of Trustees or illegality in the appointment of Trustees or their proceedings shall not invalidate any prior act or decision of the Board.

7. LAWFUL PURPOSE :

A Trust may be created for any lawful purpose. The purpose of a trust is lawful unless it is

a) Forbidden by law, or (b) is of such a nature that, if permitted, it would defeat the provisions of any law, or (c) is fraudulent, or (d) involves or implies injury to the person or property of another, or (e) the Court regards it as immoral or opposed to public policy. Every trust of which the Purpose is unlawful is void. And where a trust is created for two Purposes, of which one is lawful and the other unlawful, and the two Purposes cannot be separated, the whole trust is void.

8. FUNCTION OF THE TRUST :

a) The trust will never acts which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country . Sec 4 which the Trust and the trustees are responsible for that and come under the all punishable law (CRPC and IPC).

b) The Trust will never acts like micro financing and money laundering (Act-2012) economic offence /crime in connection with sec 20 and in nature and shall not obtain any donation or like that from abroad without getting the permission of FCRA Act from the Central Govt. / the competent Govt. authority which the trust and the trustees are responsible for that and come under the all punishable law (CRPC & IPC) .

c) The Trust shall never augment and / or borrow money from the Public Or open market by announcing different attractive financial investment schemes .

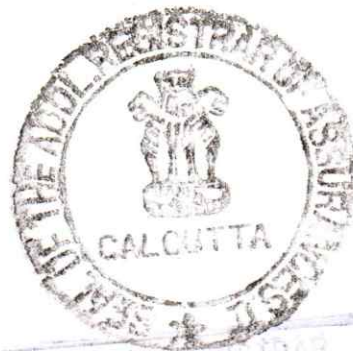
d) All Donation & Gift from any one individual or institution or any corner shall be accepted by maintaining all legal norms and valid documents / receipts .

e) Date Of Commencement : 14th September, 2022

9. TRUST ADMINISTRATION AND POWER TO THE BOARD:

A. The Board of Trustees shall have power to:

I. To administer the Trust, its properties and affairs and do all the things which will fulfill the performance of the objects for which the Trust is established and for this purpose the Board can apply the whole or any part of the Trust property towards the payment of the expenses of the Trust.

- II. To open one or more bank accounts and operate the same or provide for operation of the said accounts by any two among them authorized on their behalf.
- III. To invest the Trust funds in the manner not prohibited by any provisions of the Income Tax Act, 1961.
- IV. To buy, mortgage, grant, lease, hire or otherwise alienate all or any of the properties of the Trust in its discretion for adequate consideration, so however any sale or alienation of immovable properties of the trust can be done only after obtaining the prior approval of the Commissioner of Income Tax and District Judge .
- V. To receive, collect and enforce recovery of all monies due or payable to the Trust and grant receipts and discharges therefore.
- VI. To settle, compromise or compound any disputes or refer the same to arbitration or litigation.
- VII. To receive voluntary contributions from any person or persons from India after complying with the statutory formalities, with proper Norms & Legal Documents by way of donation, gifts or in any other manner and to hold the same upon Trust for the objects set forth herein.
- VIII. To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the Trust.
- IX. The Board shall have power to make and rescind rules and regulations for the management and administration of the Trust
- X. No Trustee shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund / property.
- XI. The Board of Trustees will follow the instructions given by any donor who makes substantial contribution towards furtherance of the objects of the Trust, so long as such instructions are not detrimental to the attainment of the objects of the Trust and are in conformity with the provisions of the Income-tax Act, 1961.
- XII. For the management and administration of the Trust, the existing Trustees shall hold the office for life. The management and administration of the trust will be guided by the Chairman (Managing Trustee.).

XIII. All aims / objects / purpose of the trust herein stated above shall come into effect / force after necessary approval of the competent Govt. Authority in the cases where affiliation / permission / license / sanction is required.

B. ROLES AND RESPONSIBILITIES AND POWERS

The Roles, Responsibilities and powers of all these officers is defined below. In addition to these, the Chairman (Managing Trustee)may grant additional roles, responsibilities and powers to any of the Trustees.

I. CHAIRMAN (MANAGING TRUSTEE) :

The Chairman (Managing Trustee) is authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, Government Institutions and other organizations, on behalf of the Board of Trustees. The Chairman (Managing Trustee)shall have all the residuary powers, not explicitly assigned to any of the other officers in these presents. The Chairman (Managing Trustee) is empowered to remove any Trustee from the Trust and its offices, if He/ She finds that He /She activities are not congenial to the activities of the Trust (the Board has to prove that His/ Her activities are not congenial to the activities of the Trust and before removing Him / Her the Chairman (Managing Trustee) has to take an approval from the Board by a meeting after consulting with other Trustees).

The Chairman (Managing Trustee)is responsible for ensuring that the Trust pursues its Objects and for maintaining the dignity of the Trust organization and shall use his/her influence to promote the activities of the Trust.
